Medium risk = stripping a non-soiled bed, patient contact (hand shake), setting up O_2 or nebulizers, observations, setting up IVI and giving injections, removing gloves, bed baths and washing patients. **High risk** = dealing with bodily secretions, bedpans, commodes, suctioning, tracheostomy care, infected wound dressings, phlebotomy and cannulation.
