

FoI request re: attempted suicide/self-harm admissions

Thank you for your request for information relating to the number of attempted suicide/self-harm admissions in 2019 and 2020.

This was received on 3 July 2020 and has been dealt with under the terms of the Freedom of Information Act 2000.

Please find our responses below:

## **Request:**

Please can you provide the number of attempted suicide/self-harm admissions to the trust in the months outlined below:

- (i) 1<sup>st</sup> January 2019 to March 31<sup>st</sup> 2019
- (ii) April 1<sup>st</sup> 2019 to Jun 30<sup>th</sup> 2019
- (iii) 1<sup>st</sup> January 2020 to 31<sup>st</sup> March 31st
- (iv) April 1<sup>st</sup> 2020 to June 30<sup>th</sup> 2020

If possible can you provide a breakdown of age group; over 18, under 18.

Please note we cannot provide figures on the number of attempted suicides admissions as we are unable to identify suicide attempts specifically, we are only able identify attempts at self-harm.

The figures below are for Attempted Self-harm admissions to the trust.
