For the period 01/04/2021 – 31/03/2022, 329 miscarriages.

What is the total number of pregnant women you cared for during the same period? For the period 01/04/2021 - 31/03/2022, the total of pregnant women was 4043.

Request 4:

What is the number of asylum seeking and/or undocumented migrant women who had a stillbirth while in the care of your trust in the latest one year period you have data available for?


